Deed of lease of Land & Building

This deed of lease made this 28th day of June, 2006 between Sh. Ram Dev Singh Kaswan S/o Late Sh. Jeeta Ram R/o VPo- Nayasar District Jhunjhunu, Called "the Lessor" (Which expression shall include their respective successor, heirs, administrators, executors and assigns) of the part and Chairman (Umash Kaswan) Jai Public School (Run by Jai Prakash Kaswan memorial Shikshan sansthan) hereinafter called "the Lease" (Which expression shall include his successor, heirs, administrators and executors) of the second part.

THE LESSEE hereby agrees with the lessor as follows: -

- (a) To pay the said rent, free and clear of all deductions, on the 15th day of every current month in advance during the term of the lease; such payment shan be made at the address of the lessor as aforesaid & the aforesaid rent would be increased by 15% after every three year from the date of such lease agreement.
- (b) To pay for and discharge and satisfy all rates, taxes, assessments and impositions which are now or during the said term be hereafter imposed or assessed on the said premises, or the lessor or the lessee in repect thereof, by the authority of Government or otherwise.
- (c) At all times during the term of the lease to keep and maintain the premises clean, tidy, healthy, wind and watertight in all seasons and further in good and substantial repair, reasonable wear and tear and damage by fire or storm excepted.
- (d) To replace all broken fittings and fixtures by equally good or better substitutes and not to make any structural additions or alterations to the demised premises without the consent of the lessor first had and obtained in writing.
- (e) To permit the lessor, his servants and agents at all reasonable hours to enter into the property to inspect the condition or to leave notice of all defects to be repaired.
- (f) At all times during the said term to use and occupy the demised property as a school Building & School Playground and any lawful or essential purpose for school activities only and not to keep any paying guests or share accommodation with outsiders etc. nor to carry on or permit to be carried on any offensive or prohibited trade or business in the said premises.
- (g) Without the consent in writing of the lessor, not to assign or part with his leasehold estate or interest in the said premises created under these presents nor sublet the same or any part thereof to any person or persons whomsoever, or make any structural addition or alteration therein.

That the lessee, paying the rent hereby reserved and observing and performing the conditions and covenants herein contained, shall quietly and peaceably hold, possess and enjoy the said premises during the said term without any interruption and disturbance by the lessor or any person claiming under or in trust for him. Provided, however, and it is expressly agreed and declared by and between the parties hereto that, in case of non-payment of rent for any month beyond 2 days or in the event of breach of any of the conditions and covenants to be observed and performed by the lessee, the *lease* may at the option of the lessor stand determined when and in such an event the lessor shall be entitled to re-enter into the property and repossess the same as his former estate without prejudice to his right to recover all areal'S of rent and any damages for breach of such conditions and covenants.

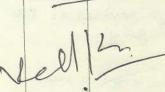
